5	Contents	Theoretical and practical fundamentals of solving difficult mixed-integer linear optimization problems (MIPs) constitute the main focus of this lecture. At first, the concept of NP-completeness and a selection of common NP-complete problems will be presented. As for polyhedral theory, fundamentals concerning the structure of faces of convex polyhedra will be covered. Building upon these fundamentals, cutting plane algorithms as well as branch-and-cut algorithms for solving MIPs will be taught. Finally, some typical problems of discrete optimization, e.g., the knapsack problem, the traveling salesman problem or the set packing problem will be discussed.

First, we show the equivalence between separation and optimization. Then, we present solution strategies for large-scale optimization problems, e.g., decomposition methods and approximation algorithms. Finally, we deal with conditions for the existence of integer polyhedra. We also discuss applications for example from the fields of engineering, finance, energy or public transport.

The mathematical theory is confronted with the lack of regularity, as initially smooth solutions may develop discontinuities (interpreted as shock waves) in finite time. We study scalar conservation laws, for which there is a classical well-posedness theory of entropy solutions due to Kruzhkov. Later, we investigate hyperbolic systems with a special focus on the Riemann problem, which requires a detailed understanding of the geometry of shock and rarefaction curves. Particular emphasis will be on the discussion of models of gas flow and thermodynamics, such as the compressible Euler equations.
